

Privacy Policy

- **Scope of Use**

Apotec & Nushine Privacy Statement and its relevant informing items only apply to the websites which Apotec & Nushine owns and operates. Apotec & Nushine website may contain a number of links, or goods or services provided by other cooperative partners and individual stores. With regards to the Privacy Statement and the informing items related to personal data protection of such linked websites, the websites of other cooperative partners, or the online shops of individual stores, please refer to each of the linked websites, cooperative partners' websites or the websites of the individual stores' online shops.

- **The Purpose and the Classification of Personal Data Collection**

In order to provide e-commerce services and/or after-sales service, to perform statutory or contractual obligation, to protect the rights and the interests of the parties and relevant stakeholders, to conduct marketing, customer management and service, and to operate the registered business items or the business stipulated in the organization's articles of association, depending on the nature of the various services, Apotec & Nushine may collect your name, contact information (including but not limited to telephone numbers, e-mail, and address, etc.), any information which is required to complete collection or payment, IP address, and other personal data which can be used to directly or indirectly recognize user's identity. In addition, to improve service quality, Apotec & Nushine will record the user's IP address and the browsing activities on Constant Pharmacy's related websites or APPs (for example, the hardware and software the user use, the web pages the user clicks on, the APPs the user downloads) and other related information in accordance with the

nature of the services provided, and the information will only be used for traffic analysis and network behavior surveys in order to improve the service quality of Constant Pharmacy's related websites, and will not be connected to specific individual.

- **Use of Personal Data**

The personal data that Apotec & Nushine collects, which is sufficient to recognize user's identity, are only provided for the internal use, processing in accordance with the purpose of personal data collection, except with the prior description, or for the purpose of completing the services provided or fulfilling contractual obligations, or in accordance with relevant laws and regulations or the competent authorities's order or demand, otherwise Apotec & Nushine will not provide any personal data which is sufficient to recognize user's identity to any third party (including domestic and foreign), or use the personal data for other purposes other than the original purpose of collection. Apotec & Nushine will continue to maintain, process and use relevant information.

- **Information Security**

Apotec & Nushine will maintain the safety of the personal data of Apotec & Nushine with reasonable technical and procedure which meet the industry standards.

- **The Rights of the Party**

The party may request any inquiry or review of the party's personal data or request for a duplicate. If your personal data has changed, or you have found that your personal data is incorrect, you can request Apotec & Nushine to modify or correct it. When the specific purpose of collecting personal data no longer exists or time period expires, you can request to delete, stop processing or use your personal data. However, the aforementioned procedure is not applicable when it is necessary for Apotec & Nushine to perform an official duty or fulfill a legal obligation.

- **Cookie**

In order to facilitate users, Apotec & Nushine website may read the cookie data stored in user's computer. Users can cancel or limit the function by changing browser settings, but may not be able to use part of the website functions. If you want to know how to cancel or limit such function, please contact the Apotec & Nushine customer service center.

- **Google Analytics (analysis) Advertising Function**
